### PURPOSE OF THIS STUDY

To define and defend more effectively the Judeo-Christian worldview of the U. S. Constitution and legal system in today's Culture War:

### PRINCIPLES AND TRUTHS CENTRAL TO THIS STUDY

- TM depends heavily on its fundamentally flawed view of man's sexual nature as fluid, non-binary, and totally determined by each individual for himself.
